

## NOVEMBER 4 GENERAL ELECTION | Your Guide to the 2014 Ballot



**I**n November, voters in our state will be casting ballots to elect new faces to key leadership positions. Not so surprisingly, the road ushering in those new faces has been nothing short of drama-filled.

Voters have been inundated with television ads, yard signs and mailers advocating for individual candidates. However, voters may not be well-versed on the statewide issues that will appear on the November ballot. This guide will help you prepare for the upcoming general election.

### **Constitutional Amendments**

Each election year, the legislature has the authority to refer three measures to the electorate. This year, voters will consider three constitutional amendments that have been referred by the 89th General Assembly for consideration. The three issues are listed below by official popular name:

- **Issue No. 1:** AN AMENDMENT EMPOWERING THE GENERAL ASSEMBLY TO PROVIDE FOR LEGISLATIVE COMMITTEE REVIEW AND APPROVAL OF STATE AGENCIES' ADMINISTRATIVE RULES.
- **Issue No. 2:** AN AMENDMENT ALLOWING MORE TIME TO GATHER SIGNATURES ON A STATE-WIDE INITIATIVE OR REFERENDUM PETITION ONLY IF THE PETITION AS ORIGINALLY FILED CONTAINED AT

LEAST 75% OF THE VALID SIGNATURES REQUIRED.

- **Issue No. 3:** AN AMENDMENT REGULATING CONTRIBUTIONS TO CANDIDATES FOR STATE OR LOCAL OFFICE, BARRING GIFTS FROM LOBBYISTS TO CERTAIN STATE OFFICIALS, PROVIDING FOR SETTING SALARIES OF CERTAIN STATE OFFICIALS, AND SETTING TERM LIMITS FOR MEMBERS OF THE GENERAL ASSEMBLY.



### **State Petitions**

Two additional petitions initiated by the people of Arkansas will appear on the ballot. Listed by official popular name, they include:

- **Issue No. 4:** THE ARKANSAS ALCOHOLIC BEVERAGE AMENDMENT. This would eliminate wet and dry counties in Arkansas and allow for the manufacture, sale, distribution and transportation of alcohol statewide.
- **Issue No. 5:** AN ACT TO INCREASE THE ARKANSAS MINIMUM WAGE. This measure, if passed, would raise the state minimum hourly wage from \$6.25 to \$7.50 on January 1, 2015; to \$8.00 on January 1, 2016; and \$8.50 on January 1, 2017.

## Benton County Measures

Finally, Benton County voters will find another measure or two on their ballots, concerning the rural ambulance funding issue. The official title of the ordinance that will be presented to all Benton County voters is:

- **Referred Ordinance No. 1:** *An Ordinance Establishing An Ambulance Service Improvement District Co-Extensive with the Boundaries of Benton County, Establishing in the Quorum Court the Authority to Levy Up to 0.2 mills to Fund Such District's Operations, Referring the Matter to the Electors of the District at the November 4, 2014 General Election, and for Other Purposes.*

Only Benton County voters who live in unincorporated areas of the county will have the option of voting on an annual fee for funding rural ambulance service. The official ballot title reads:

- **Referred Ordinance No. 2:** *AN ORDINANCE ESTABLISHING AN EMERGENCY MEDICAL SERVICE DISTRICT FOR THE UNINCORPORATED PORTION OF BENTON COUNTY NOT CURRENTLY PART OF THE NORTHEAST BENTON COUNTY EMERGENCY MEDICAL SERVICE DISTRICT, ESTABLISHING THE SERVICES TO BE PROVIDED BY THE DISTRICT, ESTABLISHING FEES TO FUND THE DISTRICT,*

*INCLUDING A \$40.00 PER HOUSEHOLD FEE, PROVIDING THAT THE PER HOUSEHOLD FEE CANNOT BE INCREASED WITHOUT A VOTE OF THE PEOPLE, PROVIDING FOR THE PER HOUSEHOLD FEES TO BE INCLUDED ON THE TAX BILLS OF RESIDENTS OF THE DISTRICT, AND FOR OTHER PURPOSES.*

With the general election just weeks away, Sarah Collins, Vice President of Government Affairs for the Rogers-Lowell Area Chamber of Commerce asked Asa Hutchinson, the Republican gubernatorial candidate and Mike Ross, the Democratic nominee, the following question about their vision for making Arkansas a business-friendly state. See the question and the candidates' responses below:

### Question to the Candidates

**A myriad of issues have an impact on the business community. From education and taxes to career readiness and transportation and infrastructure challenges, business leaders across the state look to our Governor to set the tone for the business climate. What change would you, as Governor, influence to make Arkansas attractive to new businesses and improve the climate for existing businesses?**

#### Asa Hutchinson

"I want to be known as the 'jobs Governor' because a growing economy creates more resources for education, highways and a safety net for those struggling. We must send the message nationally and globally that Arkansas is the right place to do business.

First, we need to lower our high state income tax rate so we can compete with our neighboring states, all of whom have lower income tax rates compared to Arkansas. Next, we can do a better job of making sure that we provide workforce training that is effective, efficient and meets the needs of employers. In addition, I plan to have computer science courses offered in every Arkansas high school. Technology education that includes coding is increasingly in demand across economic sectors, from transportation to manufacturing to banking. Arkansas has a proud tradition of hardworking innovators that grow businesses and create jobs here at home, and computer science skills allow students to be entrepreneurs and to create their own companies.



I will reform the way we regulate industry. Recent rules from the Environmental Protection Agency will raise the cost of energy for Arkansas rate-payers and hurt manufacturing. We need to have an approach to regulations that protect Arkansans and our natural resources but also encourages growth instead of penalizing it.

I am a strong supporter of public schools and I will continue to support our teachers and students in pursuing excellence. A Hutchinson administration will approach education with high expectations and high standards. Working together, we can make Arkansas the best place to live, work and raise a family."

#### Mike Ross

"As a fifth-generation and lifelong Arkansan, I am confident in Arkansas's ability to continue to attract new businesses and to improve the climate for existing businesses. My positive vision for Arkansas includes continuing what we're doing right and focusing on how we can improve.

I will be the education governor because attracting more and better paying jobs starts with education. Businesses and industry are looking for a



skilled, trained, and educated workforce. It's why I've proposed a pre-kindergarten plan that fully funds and expands our current pre-k program.

We also need a renewed focus on career-tech. Northwest Arkansas Community College is a good example of how 2-year colleges are working to get people the training they need to fill open jobs in the area.

I've been involved with economic development my whole life as a state senator, U.S. Congressman, and a small business owner. I understand the challenges new businesses face. We can make it easier to start a new business by streamlining the process and cutting the time it takes to start a small business down by weeks. Additionally, my income tax plan will cut taxes for nearly every working Arkansan and small business in the state.

I commend Governor Beebe's leadership on developing the Quick Action Closing Fund that has led to the announcement of 30,000 jobs in Arkansas. I want to fully fund it so communities can continue to attract new businesses. I want to eliminate the manufacturing sales tax, allowing industries to modernize, update and expand their facilities in Arkansas instead of expanding elsewhere."

### Early Voting begins October 20

Early voting in Benton County will take place at the County Clerk's office, and several other offsite locations beginning October 20. Early voting at the Chamber's Lowell office will be held October 27 through November 3 from 8:00 a.m. to 5:00 p.m. Offsite early voting hours will vary by location. You may contact the County Clerk's

office for additional locations and their respective times. The Benton County Clerk's office is open weekdays from 8:00 a.m. – 4:30 p.m. and may be reached at (479) 271-1013.

### Voter ID Law

Don't forget your photo Identification when heading to the polls in November! Under Arkansas law, all voters now have to render a valid form of photo identification before casting a ballot.

The law allows for many forms of identification that will suffice. Several examples include an Arkansas Driver's license, Arkansas photo ID card, concealed handgun carry license, U.S. Passport,

state or federal government employee ID, U.S. military ID, student ID card from an accredited post-secondary institution in Arkansas, or a public assistance ID card.

If a voter is without any of these forms of identification, he or she may obtain a free Voter ID card at the county clerk's office.

If a voter cannot provide a suitable form of identification at the polls, a provisional ballot may be cast. Fulfilling the ID requirement does not exempt voters from having to register to vote by the October 6 deadline.

### What Can I do to Help?

**M**et the Pack Shack. "Like many people, we just weren't aware of the extent of the problem facing so many of our neighbors," said Bret Raymond, co-founder and CEO of The Pack Shack, a Rogers-based nonprofit and new member of the Rogers-Lowell Area Chamber of Commerce. "However, when you learn that one in five Arkansans suffer from hunger, and that one in four kids in Arkansas suffer from hunger, and that Arkansas leads the country in terms of senior citizen hunger, you ask yourself, 'What can I do to help?'" Bret and co-founder Jarod Ring spent most of 2013 asking questions, learning from local nonprofits, businesses, foundations, civic groups, and individuals regarding the root causes of hunger, the needs of the community, and existing gaps that need to be filled. The result: an innovative approach to fighting hunger that has caught the attention of many in the Northwest Arkansas area.

### Low Awareness of Hunger in Northwest Arkansas

"Nonprofits shared with us that there is a relatively low level of awareness regarding hunger in the area, and they said they could always use more volunteers," remarked Jarod. "We took that information and combined it with a high energy, hands-on activity to create The Pack Shack."

Raymond pointed out that the negative health effects of food insecurity disproportionately affect those living at lower income levels, often resulting in under nutrition and increased rates of chronic disease and obesity. The Pack Shack is working to ensure that its neighbors have food that will nourish and strengthen them. They create delicious, nutritious meals that are easy to prepare, accessible, and affordable.

### Host a FEED THE FUNNEL Party

The Pack Shack gets people together for crazy fun **FEED THE FUNNEL** parties to pack delicious, healthy, easy-to-prepare meals that are given to hunger relief groups in the communities in which the parties take place. Every one of its delicious recipes provides valuable protein and essential vitamins and minerals, meeting the stringent nutritional specifications established by the World Health Organization. Meals consist of rice, soy protein, dehydrated vegetables, and 19 vitamins and minerals. "We'll be

Bret added, "We host parties on your turf, on your time. We've hosted Friday night parties, Sunday morning parties, and even Tuesday afternoon parties. Whatever is best for the group that wants to host the party. We're very flexible."

All types of organizations have hosted **FEED THE FUNNEL** parties, including: Sam's Club, Arvest Bank, Daisy Outdoor Products, the University of Arkansas, Bentonville First Nazarene church, Springdale High School, and many others. Nonprofits in Northwest Arkansas that have received meals

introducing our new Cheesy Rice & Vegetables meal in October," commented Bret, "thanks to the incredible work of the culinary team at Tyson Foods who have helped us make our meals even better!"

"When we say that we pack meals, we literally put on hairnets and gloves and create a delicious, nutritious product from different dry ingredients," continued Jarod. "Over the past few months, we've packed and distributed more than 500,000 meals to nonprofits in Arkansas, Oklahoma and Kansas. By the end of this year, we will have exceeded 1,000,000 meals!"






