Rules and Regulations

Interpretation of the following rules shall be the exclusive right of the tournament director and/or committee and decisions shall be final in all matters.

1. **ELIGIBILITY:** Limit 2 people per boat. At least one member of the team must be 18 years or older to operate the boat. Members of the Rogers-Lowell Area Chamber of Commerce Buddy Bass Committee are not eligible to participate in the tournament.
2. **REGISTRATION AND ENTRY:** Every team must submit an entry form. Entry fees will be accepted by mail until April 28, and in person through 5 p.m. May 5, at the Rogers-Lowell Area Chamber of Commerce, 317 W. Walnut, Rogers, AR 72756, or after 5 a.m. on MAY 6, 2017 at the Prairie Creek Marina Pavilions.

Checks will not be accepted for payment after April 28, only cash or credit card.
3. **TOURNAMENT TIME:** Departure will be in sequence in which team reservation forms with appropriate fees are received. Official starting times and return check-in times are 6:00 a.m.-2:00 p.m., 6:20 a.m.-2:20 p.m., 6:40 a.m.-2:40 p.m., and 7:00 a.m.-3:00 p.m. Contestants may launch from any location on Beaver Lake; however, contestants CANNOT make their first cast until the assigned time.
4. **LATE CHECK-IN PENALTY: DISQUALIFICATION.** No excuses! Boats must check-in at official tournament flag, to be located at Prairie Creek Marina No Wake Zone on dock.
5. **FISHING LOCATION:** Anywhere on the tournament lake except within 50 yards of another contestant's boat, a public dock, or the weigh-in area.
6. **BOATS AND MOTORS:** Any boat 14 ft. or longer will be accepted if powered by an engine of 10 hp or more and equipped with a kill switch and an aerated live well. Boats may not be trailered during tournament hours.
7. **TACKLE AND EQUIPMENT:** Only artificial lures may be used. Pork-style lures are allowed. All bass must be caught on a rod and reel. **NOTROLLING!**
8. **SAFETY AND SPORTSMANSHIP:** Safe boating and fishing practices must be observed at all times. Life jackets must be worn when boat is on plane. **ALL GAME & FISH LAWS WILL BE STRICTLY ENFORCED.** All contestants are required to follow high standards of sportsmanship, courtesy and conservation. Intoxication will be cause for immediate disqualification. No alcoholic beverages or illegal drugs will be allowed in the boats during the tournament hours extending through the signing of the weigh-in form. Illegal use of drugs, commitment of a crime, or other conduct reflecting unfavorably upon efforts to promote safety, sportsmanship, fair competition and compliance with tournament rules are grounds for disqualification and/or rejection of any application for participation.
9. **SCORING:** Largemouth Bass, Spotted Bass (Kentucky), Meanmouth Bass and Smallmouth Bass will be counted for total weight. The total stringer weight per team will determine finishing place. Any Largemouth Bass, Smallmouth Bass, or Meanmouth Bass under 15" and any Spotted Bass (Kentucky) under 12" presented for weigh-in will cause a two (2) pound penalty subtracted from the total weight, plus the loss of the short fish. Bass will be measured on a flat board, mouth closed and tail to touch the line. **FIVE (5) FISH LIMIT PER TEAM***. Any # of fish over the five fish limit presented for weigh-in, the weighmaster will begin culling with the largest bass. A penalty of 0.5 pound will also be deducted from the stringer weight for each dead fish. Any frozen or iced fish presented for weigh-in will result in immediate DISQUALIFICATION. Use of any electronic implanted device(s) (bugging) used to locate fish will result in team DISQUALIFICATION. Contestants must be in sight of their partner during tournament hours. Bass will be weighed on two scales with same calibration.
10. **TIES:** Total weight category, lowest boat number, and total number of fish will determine winner.
11. **POLYGRAPH TEST:** By his/her signature on this entry form and/or participation in this tournament, contestants agree to submit to and pass a polygraph test if required by the tournament committee. Refusal to submit will result in immediate disqualification. Contestants disqualified by result of polygraph test will forfeit all monies and prizes and will be banned from future tournaments.
12. **PROTEST:** Protest must be filed in writing with the tournament committee no later than 15 minutes after the conclusion of the weigh-in.
13. **TOURNAMENT CANCELLATION:** The Rogers-Lowell Area Chamber of Commerce reserves the right to cancel this tournament upon written notification to registered contestants and full refund of any tournament fees paid.
14. **FISH:** All fish become the property of the tournament committee.
